# Family Center Pre-Enrollment Fees (Excluding Back-Up Care):

\$50/child

\* Kindergarten Supply Fee = \$75/child

#### Family Center Tuition Adjustments:

- Extra Hour Charges: \$7/child for unscheduled hours in excess of 31 hours for part-time enrollment.
- Late Pick Up: Families picking up their children after the posted closing times will be charged \$1/minute per child.
   There are no vacation/sick credits. While enrolled, your account is charged the full amount regardless of attendance.
- \* Age group rate changes will take effect only after the child has physically "transitioned" to the older-age-group classroom.

- Eamily Center Tuition Payment Terms:
   Back-up care is limited to 20 days per child per year.
   Each family will complete a Citi Family Center Enrollment Packet each year identifying program selection, tuition, method of payment, and emergency contacts.
- \* All services are paid in advance. Payment is due bi-weekly by payroll deduction.
- \* For families using payroll deduct: If the paycheck does not cover the tuition amount due, the payment is made directly to the Family Center and is due on the Friday payroll deduct date. If tuition is not received when due, a late fee of \$5 per working day may be added to the tuition until it is paid in full. When a payment is delinquent for one week, the space can no longer be reserved, and the child cannot attend the center until the balance is current.
- \* A \$25 fee will be charged for a check returned for insufficient funds. If this occurs more than once, the Family Center may require payment by another
- method for enrollment to continue.
- \* For families enrolled exclusively in the back-up care program, payment is due at the time of drop off for care scheduled within that week.
- A two-week written notice is required when withdrawing from the center.
- Any tuition in arrears at the time of withdrawal will be automatically deducted by payroll deduction.

PLEASE NOTE: Citi subsidizes all tuition for their employees and must report the fair market value to the Internal Revenue Service. This may or may not have tax implications for you. You are advised to consult a tax advisor if you have any concerns.
